 - c. Approval of Minutes- motion, by Elizabeth, second by Kristine
2. Acknowledgements/Accomplishments –
 - a. Mallinckrodt hit with large fine for not reporting excessive opioid dispensing (Fox 2)
 - b. Today is Emily's last meeting, will be moving on to a new position teaching
 - c. Health Dept is conducting county wide needs assessment, received 1100 responses back already
 - d. We are still accepting donation for the Arnold Food Pantry (24 cases of beverages donated by Mobile on the Run)
 - e. First Parent Support Group 2 weeks ago- about 13 people attended to share stories
 - f. Sign-up sheet for events being passed around, needs are highlighted in yellow
3. TRAINING/GROUP DISCUSSION (20 minutes):
 - a. Jerry Williams, JC Sheriff's Dept, alcohol compliance checks with leftover grant money, last round is in August, 2 rounds already done

Topic: "Alcohol Compliance Checks" (JCSO)

 - Find youth with no criminal record, conduct background check, then take to a retail outlet (Home Depot) and have people guess their age, have to guess 18 or 19.
 - No deception at the retail outlet or restaurant, they admit they are 18 or 19.
 - Youth are in line of sight the entire time with an undercover officer inside as well.
 - They are looking to catch the clerk that overrides and still sells the alcohol.
 - If a sale, youth will go to officer's car and give product to them so it is only in the youth's possession a short time.
 - The officer will then go over the violation of the sale of alcohol to a minor and then that info will be provided to the alcohol board
 - 3 violations in a year and then loss of license (fines increase each violation).
 - Officers are there to educate as well (ex: show them that the license is sideways for those under 21 & deliver coalition follow-up packets).
 - Coalition advertises in Leader for those businesses that did not sell to minors.
 - Desoto PD conducting their own checks using internal funds.

- b. Teen Advisory Board (TAB)/JMCF Youth Leadership Development Grant-
 - i. 5 youth, Alicia, Gabby & Beth are attending CADCA Mid-Year (Atlanta)
 - ii. Putting flyers in water bottles to get more kids to join
 - iii. Marijuana campaign- reach out to neighboring coalitions to work together
- c. AMA Healthy Living Grant (Rx Safety Education Campaign)-
 - i. Posters (for physician offices) and yard signs with drop box locations, website is more interactive for kids.
 - ii. Pill bottle magnets also purchased to advertise drop box locations with money saved.
 - iii. Staff to ride along with Mercy contact to deliver materials to physician offices.
 - iv. Staff to present at Walgreen's pharmacy manager meeting to distribute materials.
- d. Drug Free Communities-
 - i. 2/3 rounds of alcohol compliance checks completed (20 businesses checked, 6 sold) – Ad in this week's Leader to advertise businesses that did NOT sell.
 - ii. Table tents created & counter mats updated with 8 permanent drop box locations
 - iii. Funds available for mailers, hockey pucks/ stress balls for community events to hand out
 - iv. Collaboration with Comtrea & other partners- use of service dogs "The Courage to Speak" (evidence-based curriculum). JCDPC will implement the parent piece (details will be provided at August coalition meeting)
