Topic: "Courage to Speak" (COMTREA – Laura Casey)

The "Courage to Speak" is a model that engages home, school and communities to keep our children safe from drugs. This is most successful when multiple pieces are integrated together in a community. The prevention program that is for 4-6th grades is centered around a book that Mrs. Ginger Katz wrote Sunny's Story about her son's struggle with addiction through the eyes of their dog. The middle school program is centered around a presentation that talks about Ginger's story. The high School Curriculum focuses on decisions making, etc. There is also an after school curriculum, a parenting 101 class, and a drug free family night.
