Referred through police report, community complaint or school incident report. Respond to offenses by putting youth on pending probation, informal probation, formal probation, in detention, or referring to Division of Youth Services. Students may also be referred to individual/family counseling, drug assessment, anger management, alternative school, mentor program, Minor in Possession Program (first-time alcohol-related offenses), Faith Foundation (shelter care), community service, Girls Matter program, psychological evaluation, and online classes.
