## **Reports:**

## Financial budget

- Report handed out: \$9000 for DFC campaigns (needs to be spent by September 30<sup>th</sup>) &, \$10,000 grant to target rx drug safety (funds to be spent within 1 year Actual date to be confirmed)
- 3 rounds of compliance checks for officers is funded under DFC; last checks were completed in 2015
  - Have only provided positive promotion of businesses that did not sell to minors in the past (negative publicity could affect our relationships) – Newspaper ads might be an idea for funds
  - Sheriff's office does the check and sends to state but no prosecution has occurred, but still has value to point out a flaw and provide training
- Match is doing well, have until end of Sept, have \$127,431 and need \$187,500

TAB (Alicia)- stickers could be used in the Leader

## Coalition (Jillian)-

- Updates on new logo (brochure, business cards, etc...) See notes in Old/New Business
- Healthy Living grant just received (\$10,000) "candy crush" theme for posters (pediatrician offices) & possibly make it interactive. Drop box locations to be advertised on posters & billboards that target older audience

- has evaluations to give coalition
- asked students what the takeaway was
- If they were caught with alcohol, have 2 different programs for 1<sup>st</sup> offenders and then repeat offenders
- need newer video to replace Matt Damon video; Gabby has access to a more recent video that has famous people in recovery and University of Utah has interactive program, Meth Mouse, that shows the effects of chemicals on the brain;
