Acknowledgements/Accomplishments National Night Out (Byrnes Mill); Community Collaboration Meeting w/ JCDPC, JCHD & COMTREA to address opioid epidemic (looking for agencies to be around the table); Multiple Community Focus Groups in Jefferson County (facilitators= JCHD, Mercy, JFCAC & COMTREA); Jim Epsie started at the meals on wheels and went to 17 homes in 2 hours; Kristine Bogue shared that Jefferson College was awarded a grant for domestic violence and dating violence and will be hiring staff to manage that; Encounter Recovery Services is a new service for Jefferson County to help with recovery and treatment (run out of Cross Point Church in Festus but not a religious affiliation);

# 3. TRAINING/GROUP DISCUSSION (20 minutes):

Topic: "Suicide Prevention" (Elizabeth Makulec) – There is a Suicide Prevention Conference on Friday Sept 14 at the Quality Inn in Festus. KUTO stands for Kids Under Twenty One. Missouri's suicide rate is one of the highest and suicide is the 10<sup>th</sup> leading cause in the US. As far as the means of suicide in Missouri, over 50% were completed by suicide. Twice as many people died by suicide than by homicide in Missouri. The community impact: one death by suicide affects over 200 people and these are the survivors of suicide. If people get into a crisis and get the help they need, they will probably never be suicidal again. Asking someone about suicidal intent lowers anxiety, opens up communication and lowers the risk of impact of suicide. Most suicidal people communicate their intent sometime during the week preceding their attempt. People who talk about suicide may try or even complete an act of self destruction. Suicide is one of the most preventable causes of death and almost any positive action can prevent that. Suicide prevention hotline: 1-800-273-TALK(8255). Text 741741: HELP. Suicide most often occurs when stressors exceed current coping abilities. If you sense
