2. 3. TRAINING/GROUP DISCUSSION (20 minutes):

Topic: "Teen Challenge Women's Ministries" (Holli Evans)- birthed in 1958 who got noticed from a man who went into a court room to tell young people about God. Four Centers in Missouri, Arkansas, Mississippi, and Tennessee and in many other countries. Geared towards teens but there are men and women's houses. Are a work study program and they teach life skills. There is a \$1,000 entry fee that is requested but not demanded. Minimum of 13 months but is voluntary. Have micro enterprises to help those that can't pay.

4. Reports (15 min.)

- a. Executive Board- *Have been looking at sustainability as we have the last year. Voted to approve JCHD's MOU on December 1st which included not only staff but also some programming money; In need of EB members.*
- b. Teen Advisory Board (TAB)/JMCF Youth Leadership Development Grant- *6 new members so far (11 came to the meeting Monday). We talked about updating some of the PROM Campaign materials like the flyers and stickers to go out next semester. We also discussed our teen retreat day before the winter break ends.*
- c. AMA Healthy Living Grant (Rx Safety Education Campaign)- *Survey to go out and final report is due on March 17th*
- d. Drug Free Communities- *Submitted budget revision documents to SAMHSA*

- a. General Coalition- **Event sign up: Courage to Speak Night and Get Healthy DeSoto night**
- b. Partners- **Missouri Student Survey registration going on now. So far Fox, Northwest, Sunrise, and Crystal City have signed up. We need the other districts to register. In the next few weeks we need to work on the other Jefferson County districts. It is grades 6-12 and done on even years. Takes about 30 minutes for students to take and all the data is reported in aggregate so we only see Jefferson County data. Schools will get**
