 - Will ask MO Network for funds if approved by Windsor & coalition
 - Mercy's correspondences regarding nurses & Narcan:
 - Nurse can't administer medications that they don't have a valid physician order for
 - Think that a standing order should work
 - Each school district should adopt their own policy (from the board of nursing)
 - Rockwood School District? Kristin is looking into their policy
 - Pevely and JCSO approved Narcan training
 - Denise spoke with Marge Cole: maybe need to include who the Narcan would be for? Students, staff, and potentially parents who might be on campus. Once we get some schools on board and find out their plans, Marge is in charge of a newsletter and could potentially put in a blurb about how those schools are implementing.
 - Denise is sending out an email to lead school nurse group to find out which schools are utilizing Narcan.
