Acknowledgements/Accomplishments – ***TAB members spoke to representatives on Capitol Hill about electronic cigarettes/JUULing concerns in their schools and did an amazing job; JCDPC & NCADA have been invited to apply for Jefferson Foundation's Proactive Portfolio (JCDPC= Safe Medication Storage/Usage/Disposal Campaign, TAB & Developmental Assets Pilot Program); Stephen Sutler's application to become a Peer Support Specialist has been accepted by Missouri Credentialing Board; Annual Chillingo (chili and bingo- unlimited) at Lemay Gardens with NA; PDMP passed in House;***
3. TRAINING/GROUP DISCUSSION (20 minutes):

***Topic: "Care Connections" (Lauren Stone) : Care Connections is a non for profit in Arnold and is affiliated with St Johns Lutheran Church in Arnold. Lauren is a case manager who is currently running 8 support groups: grief support (evening and day time), Loss of a spouse course, grieving through the holidays course, Strengthening needs parenting class, Divorce care course for parents and adults, Mommy and wee course (support for mothers and young children), Parenting a second time around (grandparents and foster parents taking care of family members/children), Single and parenting will be starting after the divorce course, a Foster Friday's course will begin in March. Some future support groups will include: before divorce (helps to reach a decision for the future of a marriage), grieving the loss of a loved one to drug use, and support for those suffering from miscarriage and infant loss/infertility. **The process for case management is usually call and does a computerized intake assessment. Bases things on their strengths and needs and then they see what could be worked on and then what programs could be utilized. Those who attend courses do not have to be a part of the case management piece.**

**NCADA has a wellness council who is hosting a Mocktails event: Sans Bar- alcohol free event for people to socialize on March 1<sup>st</sup> for \$20 @ 3<sup>rd</sup> Degree Glass Factory for unlimited mocktails and other entertainment;**  
**FBI has partnered with DEA will to show Chasing the Dragon at Festus Theater on March 24<sup>th</sup> and will be having an event paired with showing the movie at 4pm.**
