 - a. Topic: "Care Connections Updates" (Lauren Stone)- Affiliated with St. Johns Lutheran and a not for profit here in Jefferson County. They work with families on specific goals whether that is finding housing, bettering their lives, being able to get children back into their custody, support groups for families. It is to help to connect clients to resources, support services and their community to foster healthy living. The services include: counseling, grief share, divorce care, cancer support, mommy & wee, foster Fridays (for families), single and parenting, parenting a second time around and strengthening families. The services are offered at no cost to those in need. Clients can be referred and/or call to inquire about their needs. They do need to register for
