3. TRAINING/GROUP DISCUSSION (20 minutes):

Topic: "Addiction Treatment & Confidentiality" (Cynthia Weber- AAC) : Discussing the issues those who are using face, worrying about their information being leaked and someone finding out if they try to seek treatment. She also wanted to discuss HIPPA and what you decide to disclose is up to you, your privacy is your right. We need to know our boundaries as professionals when we interact with people in the field. Just because employees might be under the same umbrella does not mean they can discuss a patient between settings (ie a mental health arm should not be discussing a patient's substance use disorder with the medical arm of an agency). It is always best practice to let the person dealing with substance use disclose what they choose about seeking treatment, recovery, etc so don't share things about someone on social media even if you are not bound by HIPPA, there are social ramifications that could come up when you share things via social media. The charges are per transaction so for every person you text, snap chat, etc you can be charged that fine (so if it were a \$10,000 fine and you texted 10 people, that would be a \$100,000 fine)
